



 - (1) Must be a startup set up after January 1, 2016
 - (2) It shall not be a startup/legal entity/academic research institution/person from China or a startup established by people, legal entities or other institutions in China from a third place to invest in Taiwan.
 - (3) The source of funds shall not include funds from a third-area enterprise, which refers to a person, juristic person or institution in China that directly or indirectly holds more than 30% of the shares or total capital contribution of the third-area enterprise; or having the ability to control the third-area enterprise.
2. The participant must own the intellectual property rights of the product, technology or solution or have obtained legal licensing access.
3. Should The company fail to meet any of the eligibility requirements, The company unconditionally accepts to forfeit its place in the competition at the request of the organizer; if such violations are found after The company wins an award, The

company agrees to unconditionally forfeit all awards and return the monetary prizes to the organizers.
